

Frequently Asked Questions

What is a Power Manager event?

When summer or winter temperatures are extreme, demand for electricity increases and can cause strain on the grid. The Power Manager program is designed to help reduce energy use during times of high energy demand. This decreases the use of less efficient and more expensive energy sources.

How often do Power Manager events occur and how long do they last?

Events may occur a few times per month from April through October or November through March when electricity demand reaches peak levels. If the weather is mild, events may not occur at all. Events typically last two to three hours.

How will my thermostat be adjusted?

At the start of a Power Manager event, your thermostat will be automatically adjusted by a few degrees – higher during the hottest days and lower on the coldest. On some event days, your thermostat may be adjusted by a couple of degrees prior to the event start to pre-cool or pre-warm your home to make the temperature change during the event less noticeable. Once the event is over, your thermostat will return to its original setting.

Does the smart thermostat option affect my electric bill?

Typically, the energy usage on your bill remains the same since we are simply shifting your air conditioning or heating system's usage to a different time of day. This reduces its runtime during peak demand periods and helps us reduce the use of less efficient and more expensive power sources needed to meet electricity demand. This also helps preserve natural resources and delay the need for more power plants.

When will I receive the bill credit for enrolling?

Your \$150 credit will appear on your bill within two billing cycles of being accepted into the Power Manager program. You will also receive a \$50 bill credit following the anniversary of your enrollment each year that you remain on the program.

When could a Power Manager event occur?

Power Manager is designed for use on days when the demand for electricity reaches peak levels.

What if I don't want to participate in an event?

During an event, you can opt out by manually adjusting your thermostat or by using your thermostat's mobile or web apps.

What should I do if I no longer want to participate in the program?

Send an email to support@powermanagertstat.com requesting to end your participation in the Power Manager smart thermostat option. Once you have been taken off the program, your thermostat(s) will no longer be controlled, and you will not receive the annual participation incentive.
